Report to Cratfield Parish Council

The Internal Audit of the Accounts for the year ending 31 March 2020

1. Introduction and Summary.

- 1.1 The Internal Audit for the year 2019/20 was undertaken during the period of 'lockdown' following the coronavirus pandemic; at that time travel was severely restricted, social distancing was in place and many Clerks and Councillors were having to self-isolate.
- 1.2 In view of this unprecedented situation, the essential information required for the completion of the Internal Audit was e-mailed by Mrs Sally Chapman, the Clerk/Responsible Financial Officer (RFO) to the Internal Auditor, who undertook the work remotely/electronically. All relevant published data held on the Council's website was accessed by the Internal Auditor. This detailed Audit Report and the Annual Internal Audit Report within the Annual Governance and Accountability Return (AGAR) were accordingly completed. Any areas that could not be covered as a result of these remote-working arrangements have been recorded in the reports in order that they can be addressed at a later date, either at the next scheduled internal audit or when circumstances permit.
- 1.3 The Internal Audit work undertaken confirmed that during the 2019/20 year the Council maintained effective governance arrangements including a robust framework of financial administration and internal control. The Council has continued to ensure that effective and efficient financial administration is in place. A wide range of formal policies and procedures are in place to assist in the Council's overall management and control.
- 1.4 By examination of the 2019/20 accounts and supporting documentation it was confirmed that the Clerk, in the role as the Council's RFO, satisfactorily undertook the administration of the Council's financial affairs and produced satisfactory financial management information to enable the Council to make well-informed decisions.
- 1.5 The Accounts for the year confirm the following:

Total Receipts for the year: £9,132.97
Total Payments in the year: £3,937.61
Total Reserves at year-end: £10,818.44

1.6 The Annual Governance and Accountability Return (AGAR) was examined and the following figures agreed with the Clerk for inclusion in Section 2 Accounting Statements 2019/20 (rounded for purposes of the Return):

- 1.7 Sections One and Two of the AGAR are due to be approved and signed at a forthcoming meeting of the Council. The Internal Auditor has completed the Annual Internal Audit Report 2019/20 within the AGAR.
- 1.8 The following Internal Audit work was carried out on the adequacy of systems of internal control in accordance with the Audit Plan. Comments and any recommendations arising from the review are made below.
- 2. Governance, Standing Orders, Financial Regulations and other Regulatory matters (examination of Standing Orders, Financial Regulations, Code of Conduct, Formal Policies and Procedures, Tenders where relevant. Acting within the legal framework, including Data Protection legislation).
- 2.1 The updated model Standing Orders, produced by the National Association of Local Councils (NALC), were considered and adopted by the Council at its meeting on 11 September 2018 (Minute 6a refers). The Standing Orders were also reviewed and approved by the Council at its meetings on 12 March 2019 (Minute 6k refers) and 10 March 2020 (Minute 6k refers).
- 2.2 Financial Regulations are in place. The Regulations were reviewed by the Council at the meeting held on 10 March 2020 and revised to reflect the latest model Financial Regulations published by NALC in August 2019 (Minute 6d refers).
- 2.3 The Council's Minutes are very well presented and provide clear evidence of the decisions taken by the Council in the year.
- 2.4 The Council is registered with the Information Commissioner's Office (ICO) as a Fee Payer/Data Controller for the provision of council services under Data Protection legislation (Registration ZA356518, expiring 21 May 2020, refers). The Council demonstrates good management practice by the adoption of Data Protection policies, procedures and documentation, including a Data Information Audit Policy, Data Protection Privacy Policy, Allotment Tenants Privacy Notice, a Staff, Councillors and Role Holders Privacy Notice and a General Data Protection Awareness Checklist for Councillors.
- 2.5 The General Data Protection Policy was also reviewed and approved by the Council at its meeting on 10 March 2020 (Minutes 6e refers).

- 2.6 The Council demonstrates good practice by adopting and maintaining other formal policies and procedures, including a Planning Procedure Policy, Publication Scheme Policy, Allotment Tenancy Policy and a Play Area and Millennium Meadow Policy, all of which were reviewed and approved at the meeting held on 10 March 2020 (Minute 6 refers).
- 2.7 The Council also demonstrates good governance practice by periodically reviewing and re-adopting the Code of Conduct, which details the requirements and responsibilities placed upon each individual Councillor. The Council reviewed and readopted the Code of Conduct at a meeting held on 10 March 2020 (Minute 6c refers).
- 2.8 The Council is making appropriate preparations to ensure that the new website accessibility regulations will be complied with no later than 23 September 2020. The Clerk/RFO reported on this matter to the Council on 10 March 2020 and confirmed that she would be attending training sessions on this matter in order to ensure the Council complies with the new accessibility requirements (Minute 10a refers).
- 3. Accounting Procedures and Proper Book-keeping (examination of entries in the Cashbook, regular reconciliations, supporting vouchers, invoices and receipts and VAT accounting).
- 3.1 The Cashbook Spreadsheet was found to be in good order and well presented. Local Government Act 1972 (Section 137) payments and VAT payments are tracked and identified within the Cashbook. Grants and donations made in the year of account were reported to the Council at the meeting held on 10 March 2020 (Minute 5b refers).
- 3.2 The Cashbook is well referenced and facilitates an audit trail to the Bank Statements and Cheque Book counterfoils and the financial information prepared by the Clerk/RFO. In view of the Internal Audit for 2019/20 being conducted remotely/electronically, the supporting vouchers, invoices and receipts were not examined and a sample of the 2019/20 transactions will be undertaken at the next scheduled audit. The Clerk/RFO has confirmed to Internal Audit that payments made in 2019/20 were supported by invoices.
- 3.3 The VAT reclaim of £191.06 to HMRC for the period 1 August 2018 to 31 March 2019 is recorded in the Cashbook as received on 16 April 2019 and was reported to Council at its meeting on 14 May 2019 (Minute 7d refers).
- 3.4 A Statement of Variances (explaining significant differences in receipts and payments between the years 2018/19 and 2019/20) has been prepared by the Clerk/RFO for publication on the Council's website.

- 4. Internal Control and the Management of Risk (Review by Council of the effectiveness of internal controls, including risk assessment, and Minuted accordingly).
- 4.1 The Council's Internal Control Statement (including internal control arrangements and Internal Audit procedures) was reviewed by the Council at the meeting on 10 March 2020 (Minute 6f refers).
- 4.2 The Council's Risk Assessment document was also reviewed and approved by the Council at its meeting on 10 March 2020 (Minute 6j refers). The document provides an analysis of both financial and non-financial risks faced by the Council and the control measures in place to mitigate the risks identified.
- 4.3 The Council accordingly complied with the Accounts and Audit Regulations 2015 which require a review by the full Council at least once a year of the effectiveness of the Council's system of internal control, including the arrangements for management of risk, with the review suitably Minuted.
- 4.4 An Annual Play Equipment Inspection was carried out in the year; payment of £96.00 to David Bracey was approved by the Council at its meeting on 12 November 2019 (Minute 5a refers).
- 4.5 Insurance was in place for the year of account. At its meeting on 10 September 2019 the Council resolved to accept the Community Action Suffolk (CAS) Parish Protect Insurance quotation and the 3-year long-term undertaking at £299.79 p.a. (Minute 5b refers). The Employer's Liability cover and Public Liability cover each stand at £10m. The Employee Dishonesty cover stands at £25,000, which meets the current recommended guidelines which provide that the cover should be at least the sum of the year-end balances plus 50% of the precept/grants.
- 5. Budgetary controls (Verification of the budgetary process with reference to Council Minutes and supporting documents).

Precept 2019/20: £3,200 (Meeting on 13 November 2018, Minute 5c refers).

Precept 2020/21: £3,500 (Meeting on 12 November 2019, Minute 5b refers).

- 5.1 The Budget for the year 2019/20 formed part of the approved Minutes of the Council and displays the amount of the Precept for the 2019/20 year.
- 5.2 Similarly, the Budget for the year 2020/21 was considered and agreed by the Council on 12 November 2019 and the approval and the amount of the Precept is clearly recorded.
- 5.3 The Precepts were accordingly agreed in full Council and appropriate budget papers were prepared to ensure that Councillors had sufficient information to make informed decisions.

- 5.4 Good budgetary procedures are in place. Examination of the accounts and supporting documentation for the year under review confirmed that the Council prepared detailed estimates of the annual budget and of receipts and payments. The estimates for the 2020/21 year can be used effectively for financial control and budgetary control purposes during the coming year.
- 5.5 Detailed budgetary position statements (budget reports) are presented by the Clerk/RFO to meetings of the Council.
- 5.6 The Clerk/RFO ensures the Council is aware of responsibilities, commitments, forward planning and the need for adequate reserves.
- 5.7 At its meeting on 12 November 2019 the Council agreed to transfer £300 from the Play Equipment Reserve and £700 from the Village Maintenance Reserve to top up the low General Reserve (Minute 5a refers). As at the 31 March 2020 the Council's overall Reserves totalled £10,818.44, of which £9,698.35 has been earmarked as follows:
- (a) Bell Fund £68.60
- (b) Defibrillator Fund £242.76
- (c) Jubilee Fund £308.57
- (d) Play Area Equipment £1,036.00
- (e) Play Space £135.26
- (f) Village Maintenance £1,000.00
- (g) Village Sign £520.16
- (h) HHCFT Grants (Bus Shelter) £6,387.00
- 5.8 The General Reserve of £1,120.09 held at 31 March 2020 remains marginally less than the generally accepted position that non-earmarked revenue reserves should usually be between six and twelve months of gross expenditure or 50% of the precept.
- 6. Income Controls (regarding sums received from Precept, Grants, Loans and other income including credit control mechanisms).
- 6.1 Receipts recorded in the Cashbook consisted of Precept (£3,200), Wayleave (£110.66), Allotment Rents (£675.87), VAT reclaim from HMRC (£191.06), HHCFT Grant/Litterpick (£4,925), petty cash from 2018/19 (£20) and Bank interest (£10.38).
- 6.2 Allotment Rents were last considered by the Council at its meeting on 11 September 2018, when it was agreed that rents would remain at £16.25 per half plot and £32.50 per full plot (Minute 8h refers).
- 7. Petty Cash (Associated books and established system in place).
- 7.1 A Petty Cash system was not in use as at 31 March 2020, the account having been cleared and closed during the year of account. An expenses system is in place, with cheques being made out for expenses incurred.

8. Transparency Code (Compliance for smaller councils with income/ expenditure under £25,000).

8.1 Under the provisions of the Transparency Code, Cratfield Parish Council can be designated as a 'Smaller Council'.

- 8.2 Smaller Councils should publish on their website:
- a) All items of expenditure above £100. Payments included within published Minutes of Council meetings.
- b) Annual Governance Statement: 2018/19 AGAR Annual Return Section One. Published on website.
- c) End-of-Year accounts: 2018/19 AGAR Annual Return, Section Two. Published on website.
- d) Annual Internal Audit report within 2018/19 AGAR Annual Return. Published on website
- e) List of councillor or member responsibilities. Published on website.
- f) The details of public land and building assets (Asset Register). Published on website.
- g) Minutes, agendas and meeting papers of formal meetings. Published on website.
- 8.3 The Council is meeting the requirements of the Transparency Code.
- 8.4 The Local Audit and Accountability Act 2014 and the Accounts and Audit Regulations 2015 required the Council to publish a 'Notice of Public Rights and Publication of Annual Governance and Accountability Return (Exempt Authority)' on a publicly accessible website. The Internal Auditor was able to confirm that the document for the year 2018/19 was readily accessible on the Council's website and displayed the Date of Announcement, Dates of Inspection, Details of Person to contact to view the accounts and the Details of the person making the announcement.
- 9. Payroll Controls (PAYE and NIC in place; compliant with HMRC procedures; records relating to contracts of employment).
- 9.1 The Council is registered with HMRC and the payroll is operated in accordance with HMRC requirements. A contract of Employment for the Clerk/RFO is in place. A copy of the End of Year Certificate P60 for 2019/20 was presented to Internal Audit.
- 9.2 With regard to the legislation relating to workplace pensions, the Pensions Regulator confirmed on 27 October 2017 that the Council has completed a declaration of compliance under the Pensions Act 2008. The Pension Regulator has advised the Council that a re-declaration is required by 1 March 2021.

- 10. Assets Controls (Inspection of asset register and checks on existence of assets; recording of fixed asset valuations; cross checking on insurance cover).
- 10.1 A Fixed Asset Register is in place. The Register was reviewed, updated and approved by the Council at its meeting on 10 March 2020 (Minute 6b refers).
- 10.2 The Register complies with the current requirements which provide that each asset should be displayed at a consistent value, year-on-year. As at 31 March 2020, the assets are recorded at a total value of £50,717, an increase of £87 over the value at the end of the previous year, 31 March 2019, and reflects the acquisition of the Millennium Meadow Sign in the year of account.
- 10.3 The overall value of £50,717 has been correctly entered into Box 9 of Section 2 of the 2019/20 AGAR (Annual Return).
- 11. Bank Reconciliation (Regularly completed and cash books reconcile with bank statements).
- 11.1 The Barclays Current Account and Business Savings Account bank statements reconciled with the end of year accounts and agreed with the overall Bank Reconciliation.
- 12. Year End procedures (Regarding accounting procedures used and can be followed through from working papers to final documents. Verifying sample payments and income. Checking creditors and debtors where appropriate).
- 12.1 End of Year accounts are prepared on a Receipts and Payments basis and were in good order. Sample audit trails were undertaken and were found to be in order.
- 13. Internal Financial Controls, Payments Controls and Audit Procedures (Confirmation that the Council has satisfactory internal financial controls in place for making payments with adequate documentation to support/evidence payments made. Any previous audit recommendations implemented).
- 13.1 The Council has satisfactory internal financial controls in place. The Clerk provides Financial and Budget reports to Council meetings; Councillors are provided with information to enable them to make informed decisions.
- 13.2 Receipts and payments are listed in the Council's Minutes as part of the overall financial control framework. In addition, the Clerk/RFO confirmed that (a) cheque numbers are noted on the paid invoices/vouchers to assist the verification of the payment (b) invoices/vouchers for payment are signed or initialled by the Cheque Signatories in confirmation of the payment being correctly made and (c) Cheque Book counterfoils are initialled by Cheque Signatories, all as a matter of routine in accordance to the requirements of Item 6 of the Council's Financial Regulations

'Instructions for the making of payments'. These areas of control were not examined due to the Internal Audit being conducted remotely/electronically but will be test-checked at the next scheduled audit.

- 13.3 The Internal Audit for the previous year (2018/19) was received by the Council at its meeting on 14 May 2019 (Minute 7a refers). There were no issues of concern arising from the report.
- 13.4 The Internal Auditor for the 2019/20 year was formally appointed by the Council at the meeting held on 14 May 2019 (Minute 7c refers).
- 14. External Audit (Recommendations put forward/comments made following the annual review).
- 14.1 An External Audit was not required in the year 2018/19. At its meeting on 14 May 2019 the Council completed the Certificate of Exemption from a Limited Assurance Review for that year (Minute 7b refers).
- 14.2 Similarly, as the higher of gross income or gross expenditure did not exceed £25,000 in the year of account ending 31 March 2020, the Council is able to certify itself exempt from a Limited Assurance Review under Section 9 of the Local Audit (Smaller Authorities) Regulations 2015. The Council can accordingly prepare a Certificate of Exemption from a Limited Assurance Review for the year 2019/20, for submission within the due date to PKF Littlejohn LLP.

15. Additional Comments.

- 15.1 The Annual Parish Council meeting was held on 14 May 2019. The first item of formal business was the Election of Chair, in accordance with the requirements under the Local Government Act 1972.
- 15.2 I would like to record my appreciation to the Clerk/RFO to the Council for her assistance during the course of the audit work.
