- Play Area - COVID-19 Restrictions

Cllrs delivered the bags and we put down a good thickness and covered two thirds of the activity area which is about what I had estimated. I will arrange a date next week for one further bag to be delivered and the whole area will be covered. We then have the fourth bag in reserve for top-ups.
