Cllr Comment: Some pathways have been cut in the grass by David Steward. There has been fly tipping of items including old flower pots and broken car wing mirrors behind the bottle bank. Three Parishioners have been in contact complaining of dogs loose in the village. The Clerk has reported to ESC (as advised on the Police website) and requested parishioners to take photographs if seen again. ESC is investigating and contacting the owners.

d) Tree in the Play Area

Cllr Oliver – declared a pecuniary interest (potentially a customer) and made no comments.

A parishioner's garden overlooks the playing field. They have concerns about the eventual size of a young tree (horse chestnut) which is approx. 2m from their fence and some 5m tall. They would like the tree taken down at their expense and offer to replace it with 2/3 saplings at the north end of the field.

Cllr comment (from an email): I feel the tree should remain as it is good to have planting not all in one spot. Growth can be controlled by pollarding, though we would have to keep in mind this would entail a cost at some future date.

Cllr comment: I do not think the tree should be removed. It is healthy, and many Horse Chestnut trees have been lost to disease in recent years. The height of trees can be controlled by pollarding. I made the following observations at the site: the tree is 2.6m from the fence; there is a Copper Acer in the next door garden near the fence which is taller than the Horse Chestnut and in the parishioner's garden there is a tree which is as tall, if not taller, than the Horse Chestnut.

Cllr comment: I would rather leave the tree in place as it will not do a lot in the next 5-10 years and it would be a pity to have another tree removed, as it seems we have lost well over 50 from the surrounding area and gardens that I can see.

Cllr comment: I think we should retain this tree it is appropriate to a village play area. The suggestion of pollarding is worth consideration.

Cllr comment (from an email): Is the tree diseased at all? if not, we should try to preserve it, if we can as there are very few horse chestnuts that don't have the leaf mining moth. Albeit horse chestnuts can sap all the light from your garden if in close proximity - I assume this is the reason for wanting it removed. Can we come to a compromise - maybe we should suggest some heavy pollarding as mentioned? We will have to foot the bill, and once we start doing that, we would have continue doing that? And would others start asking for the same thing? If we allow the pollarding, I think it should be at their expense.

Cllrs resolved the Horse Chestnut tree to remain and to consider pollarding in the future (after further discussion at a proper meeting) *
