A. Public Forum – for Members of the Public

1. Manse Lane Flooding

Suffolk County Council's Engineer Mr. Peter Sparrow attended the meeting and discussed flooding on Manse Lane with Councillors and parishioners and how it could be prevented in the future. He informed:

- SCC had cleared the ditches, drains and pipes along Manse Lane to get the water flowing. The drains are SCC's but they do not own the ditches and the clearance by them was a one off and beyond their normal remit. The ditches are the responsibility of the home/land owners.
- The road will be monitored over winter and the community must work together to keep the drains and ditches clear.
- SCC can take action against home/land owners if their blocked ditches and drains cause flooding on the road
- If the road floods the water should clear within 12 hours, if it takes longer there is a problem and photographs should be taken and reported to SCC. If water is still standing after 2-3 days there is a serious problem.
- The Manse Lane residents will be invited back to the January meeting to report back any issues.

2. Mid-Summer Madness

A committee member from this event spoke of the plans to hold another event next year and the availability of the Millenium Meadow where it is normally held. Cllrs spoke of the wildlife area the meadow has now become and the effect it would have and discussed various other places to hold the event. This event will be discussed at the next meeting and a decision made. The Clerk advised if they wished to use the PC's public liability insurance, they must form a Council Committee and report actions and decisions to the PC's meetings.

B. County & District Councillor Reports

Cllr Stephen Burroughes gave a verbal report on:

- The County and District Council's support to the Afghanistan's refugees and their need for accommodation, and offers of clothing and toys for the Afghan refugees should be made to the appropriate charities.
- The forthcoming 'Speed & Safety' Summit to reduce speed and increase safety.
